
Another critical focus is increasing sponsorship beyond just convention support. Expanding the base

National Outstanding Young Farmer of the Year Award

Des Moines – The National Outstanding Young Farmers (NOYF) of the Year were recognized in Des Moines, Iowa at the 70th Annual Outstanding Farmers of America National Convention, February 5-8, 2025 at the Prairie Meadows Hotel. These farmers are active citizens in their community championing sustainable agriculture practices and are creating bright farming futures.

More than 30 nominations from across the nation were received from agricultural extension agents, family members, business owners and other agricultural professionals. "The quality of nominations received keeps getting more impressive each year. I do not envy the decision judges must make to determine finalists and winners," said National Outstanding Young Farmer Coordinator, Mary Johnson.

Once nominations closed on September 1, 2024, Johnson coordinated forms to be sent to a panel of five independent judges with scoring sheets. When scoring sheets are returned, a list of the top ten finalists is determined and notices are issued.

"The most fun part of my job is to inform finalists they have in fact been recognized. As we know, farmers are the unsung heroes of what makes America work. To recognize a farmer - and a young farmer at that - is always very rewarding," said Johnson.

The ten finalists making up the Class of 2025 include: Callie and Jacob Feather (AR), Kimberly and James Hawkins

(GA), Mike Singlestad and Kelly Boeddeker (MN), Olivia and Jacob White (MS), Dayna and Trey Wasserburger (NE), Andrea and Zach Heiken (NJ), Kaci and Bryan Thompson (OH), Clarissa and Adam Egolf (PA), Sara and John Wayne (WV), Jennifer and Jacob Hoewisch (WI).

The finalists arrived in Des Moines on an expense-paid trip to the convention, where they met over dinner and watched a preview of the NOYF finalist video. They also participated in in-person judging, facing a panel of seven judges – including OFA officers Cheryl and Don Hartman, Tor and Nicole Andersen, and Chris Martin. Also on the panel were Keith Mickler, past president of the National Association of County Agricultural Agents, and Ben Pullen, director of the Institute of Agriculture at Buena Vista University in Storm Lake, Iowa.

"This was a very impressive group of people," said Keith Mickler. "As an extension agent for 20 plus years, it did my heart good to see how this group of young farmers are tackling a very hard job with so much passion."

On Saturday, February 8 at the closing convention banquet, the top four farmers of the year were announced. Winners included; Kimberly and James Hawkins from Georgia; Dayna and Trey Wasserburger from Nebraska; Andrea and Zach Heiken from New Jersey and Sara and John Wayne from West Virginia.

All finalists and winners were congratulated by the more than 160 guests in attendance.

Meet the Class of 2025 NOYF Winners

Four winners were selected as National Outstanding Young Farmers of the Year out of ten incredible finalists.

Kimberly & James Hawkins

James Hawkins is the owner and operator of Lanlett Farms, a diverse agricultural operation based in Edgehill, Georgia. James is a first-generation farmer who holds a Bachelors in Business Management and Accounting from Augusta University. Initially working as an accountant, James eventually traded his suit, tie and desk for the sun, soil, and a tractor.

Lanlett Farms spans nearly 1,000 acres, with a focus on row crops (corn, cotton, peanuts, wheat, and hay) and a commercial beef cow/calf herd. The farm implements sustainable practices such as conservation tillage and cover cropping to improve soil health and water efficiency.



James has also grown a custom poultry litter hauling business and participates in local agricultural research trials. He serves as vice-chairman of the Farm Service Agency COC committee, is active in the Glascock County Farm Bureau, and volunteers as a youth sports coach. A recognized leader in conservation, James received the 2023 National Cotton Farmer of the Year Award and is a mentor for the Soil Health Institute.

Dayna & Trey Wasserburger

Trey Wasserburger is a proud first-generation rancher and owner of TD Angus, a rapidly growing cattle and farming operation based in North Platte, Nebraska. Trey founded his business in 2017 with a registered Angus herd that now exceeds 1,200 breeding females. TD Angus is one of the largest purebred herds in the country and ranks second in Nebraska for herd size. Trey sells 500 bulls annually across 30 states and operates a family-owned feedlot, where they finish 4,000 feeder cattle. His unique "conception to consumer" model completes the beef production cycle by sending finished cattle to the Sustainable Beef packing plant, which partners with Wal-Mart to sell the meat.



In addition to livestock, Trey farms 480 acres of irrigated corn for silage and implements sustainable practices like metered irrigation and using feedlot manure for fertilization. He is deeply involved in his community as a member of the North Platte Chamber board, a youth sports coach, and serves on Governor Pillen's Ag Advisory Board.

Andrea & Zach Heiken

Zach Heiken is the owner and operator of ZRH Farms, LLC, a thriving agricultural operation in Pedricktown, NJ. A first-generation farmer, Zach's passion for farming began at eight years old when he helped a local farmer with harvest, later saving every dollar he made working in construction to fulfill his dream of owning a farm. Starting with 125 acres in 2005, Zach has since grown his operation to over 4,450 acres, including row crops, small grains, and vegetables.

Today, ZRH Farms produces a variety of crops, including peppers, cucumbers, and asparagus. Through strategic use of drip irrigation and center pivots, Zach maximizes water efficiency while implementing conservation practices such as vertical tillage and cover cropping.



He is deeply committed to community involvement, donating fresh produce to local food banks and organizing efforts through Feeding America during the pandemic. Zach is an active member of several agricultural boards, including the New Jersey Vegetable Growers Association.





Sara & John Wayne Cattle


Located in central West Virginia, John and Sara Wayne have operated Wayne Cattle, LLC, a diversified farm, since 2009. Operations include a commercial cow herd, hay production, backgrounding stocker cattle, and retail meat sales. Over the past 15 years, the Wayne's have grown their farm to include 60 commercial cows and 600 backgrounded calves, while expanding their hay acreage and building a successful direct-to-consumer meat business. They also market 55 beeves annually and supply pork and lamb, with wholesale sales to local grocery stores all while also maintaining a contract with a local food bank to provide high-quality protein to families in need.

As leaders in conservation, the Waynes have worked with NRCS to implement sustainable practices such as rotational grazing, water conservation, and nutrient management. Their efforts earned them the 2021 Conservation Farm award.

Involved in various organizations. John, Sara, and their two sons, volunteer at their local church, 4-H club, and with the Braxton County Fair. Involving themselves in local, state, and national agriculture organizations helps the Waynes maintain a commitment to the farming community.

Member Spotlight

Joe Gambini & Lois Armstrong



During the 2025 OFA Convention, Joe Gambini and Lois Armstrong were presented with a plaque honoring their 60th year of being members of the OFA AND, attending their 60th OFA convention.

Thank you for inspiring generations of farms and helping cultivate a legacy of passion and progress.

"My dad came from Italy in 1907, he was a 20-year-old boy that came through Ellis Island," Joe stated. "At that time, they processed 5,000 immigrants a day."

Antonio Gambini arrived in San Francisco later that same year, not long after the 1906 earthquake, eager to make his own way in the world.

"Imagine a young guy, he didn't know English... all he knew was that America was the land of opportunity," Joe said.

In just over 10 years of being in America, Antionio Gambini purchased 180 acres of land that is part of the farm that exists today on River Road near Oakdale, California and was originally a dairyman milking 120 cows. He started planting tomatoes during World War II and the family later expanded into other areas, including the planting of trees, now with walnuts as the primary crop.

"I was born on my ranch, and I'm still there," Joe added chuckling.

The business has stayed in the family, with Joe's son Rod and his daughters Toni and Tori all involved, as well as many of their children. Joe lost his first wife, Lila, to cancer in 1985. Now, he works alongside his best friend and significant other of many years, Lois Armstrong. The business also has two corporations, Gambini Farms and Gambini Nut Company, Inc.
